NOTICE OF PUBLIC MEETING

The New Jersey Housing and Mortgage Finance Agency gave notice of the time, place and date of this meeting by electronic mail, regular mail and hand delivery on June 25, 2020 to the Secretary of State of New Jersey, The Star Ledger, The Times, and the Courier Post, and by posting the notice at the office of the Agency in Trenton, New Jersey. Pursuant to the New Jersey Open Public Meetings Act, a resolution must be passed by the New Jersey Housing and Mortgage Finance Agency in order to hold a session from which the public is excluded.

Jeffrey Feld, Esquire was invited to address the board members regarding his request for reconsideration of the Mortgage Financing Commitment for HMFA #03451, Norman Towers which was approved by the Board during the May 21, 2020 meeting. Mr. Feld reiterated the arguments he raised in his written submissions. He also referenced several recent court decisions and articles claimed to be relevant to his request for reconsideration of the Board's May 21, 2020 decision to issue a financing commitment to Norman Towers. Mr. Feld reiterated his procedural concerns that at the May 21, 2020 meeting, the Board did not hear his oral comments before deciding whether to issue a funding commitment to Norman Towers and that State agencies such as the NJHMFA need to include the reasoning behind their actions into an administrative record. Mr. Feld also stated that the substantive basis for seeking reconsideration was based on his wanting a substantive answer as to whether N.J.S.A. 55:14K-37 ("Section 37"), a provision of the Agency's enabling legislation, was repealed and replaced when the Long Term Tax Exemption Law was enacted in 1992. He also questioned whether an entity borrowing from the Agency is required to be an urban renewal entity, as well as the legal basis for that determination.

Deputy Commissioner Robert Long thanked Mr. Feld for his comments and proceeded to read the Resolution for the Board to enter into Executive Session.


